### Meeting of the Podiatry Board of Australia held on 29 July 2015

The Board held its July 2015 meeting by teleconference.

#### Accreditation and approval of programs of study for the podiatry profession

One of the objectives of the National Law<sup>1</sup> is to facilitate the provision of high quality education and training of health practitioners. The National Law sets out the roles of the Board and its appointed accreditation authority, the Australian and New Zealand Podiatry Accreditation Council (ANZPAC), in relation to the accreditation and approval of education providers and programs of study for the podiatry profession.

ANZPAC is responsible for accrediting individual programs of study. It may accredit a program of study if it is reasonably satisfied that the program and the education provider that provides the program meet, or substantially meet an approved accreditation standard and the imposition of conditions on the accreditation will ensure the program meets the standard within a reasonable time.

If ANZPAC decides to accredit a program of study (with or without conditions), it must give the Board a report about its accreditation of the program. After considering the accreditation report, the Board may approve, or refuse to approve, the accredited program of study as providing a qualification for the purposes of registration or endorsement. An approval may be granted subject to conditions.

Programs of study approved by the Board are published under [Accreditation](#) on the Board's website.

After considering reports on accreditation provided by ANZPAC, the Board approved the following programs of study.

#### University of South Australia

The Board approved until 11 July 2020 the following accredited programs of study offered by the University of South Australia as providing a qualification in podiatric therapeutics for the purpose of an endorsement for scheduled medicines:

- Advanced Pharmacology for Podiatrists (completed in 2006 or later), and
- Bachelor of Podiatry (completed in 2011 or later).

#### LaTrobe University

The Board approved until 11 July 2020 the following accredited programs of study offered by LaTrobe University as providing a qualification in podiatric therapeutics for the purpose of endorsement for scheduled medicines:

- Bachelor of Health Science/Master of Podiatric Practice (Pass and Honours), and

- Master of Podiatric Practice.

### **Endorsement for scheduled medicines – web-based case studies**

One of the Board's requirements for endorsement for scheduled medicines is completion of 15 Board approved web-based case studies.

To enable additional education providers to develop web-based case studies and have them assessed and submitted to the Board for approval for the purpose of its endorsement for scheduled medicines requirements, the Board engaged ANZPAC, to develop an assessment process for web-based case studies. Information about developing web-based case studies and applying to ANZPAC to have them assessed is published on the [ANZPAC](#) website.

After considering an assessment report from ANZPAC, the Board approved the following web-based case studies for the purpose of an endorsement for scheduled medicines:

- Web-based case studies offered by the Queensland University of Technology as part of the Graduate Certificate in Podiatric Therapeutics.
