

Transitional arrangements submission of documents form

Type: Endorsement for scheduled medicines - Pathway B

Profession: Podiatry

This form is to be used by registered podiatrists and podiatric surgeons who wish to use the transitional arrangements developed by the Podiatry Board of Australia (Board) for the *Registration standard: Endorsement for scheduled medicines* that commenced on 1 August 2018, and need to submit relevant documents by 1 September 2018.

You should refer to the transitional arrangements when completing this form. They can be found on the Board's website at www.podiatryboard.gov.au
Registered podiatrists and podiatric surgeons who at **1 August 2018**:

- have an approved qualification in podiatric therapeutics (or equivalent) not more than seven years old
- · have successfully completed web-based case studies not more than three years old
- have a signed supervisory agreement signed and dated before 1 August 2018
- have started a period of supervised practice in accordance with Pathway 2 of the previous *Endorsement for scheduled medicines* registration standard that was in effect from 1 July 2010 to 31 July 2018
- have not submitted an application for endorsement for scheduled medicines, and
- · wish to use the transitional arrangements

must submit documents relating to the first three dot points above to AHPRA by 1 September 2018. This form is to be used as a cover sheet for submitting those documents.

If **at 1 August 2018**, you have not commenced a period of supervised practice in accordance with Pathway 2 of the previous *Endorsement for scheduled medicines registration standard* that was in effect from 1 July 2010 to 31 July 2018, you do not need to submit documents to AHPRA by 1 September 2018 and do not need to use this form.

You will need to meet all of the requirements for Pathway B of the *Registration standard: Endorsement for scheduled medicines* that commenced on 1 August 2018, including applying to commence supervised practice. - I have 12 months from the date of the signed supervisory agreement to complete the requirements of Pathway 2 in the previous ESM registration standard and submit my application for endorsement, together with the required supporting documentation, including 40 log sheets for assessment.
- No extensions to the period of supervised practice will be granted.

No applications under this transitional pathway will be accepted after 1 August 2019.

SECTION C2: Documents and declaration for Pathway B

- 3. signed supervisory agreement (dated and signed before 1 August 2018).

- evidence of your approved qualification in podiatric therapeutics or a certified copy of evidence that your qualification has been assessed as equivalent to, or based on similar, competencies to an approved qualification in podiatric therapeutics
- · evidence of successful completion of 15 web-based case studies, and
- · a copy of your signed supervisory agreement.

I declare that the information in this form is true and correct.

I acknowledge and understand that under the Board's transitional arrangements:

- If I will be applying for endorsement under Pathway B using this transitional arrangement:
 - before 1 December 2018 I do not have to submit any clinical studies for initial assessment
 - after 1 December 2018 I must submit three clinical studies for initial assessment in accordance with the requirements of the new ESM registration standard and guidelines and have three clinial studies assessed by the Board as satisfactory before I finish my period of supervised practice.
- I have 12 months from the date of the signed supervisory agreement to complete the requirements of the new Pathway B and submit my application for endorsement for scheduled medicines, together with the required supporting documentation, including a portfolio of evidence.
- My application and my portfolio of evidence will be assessed against the requirements for Pathway B of the new ESM registration standard and the updated National Podiatry Scheduled Medicines List attached to that standard.
- No applications under this transitional pathway will be accepted after 1 August 2019.
